1. Who can appear for TNSCVT Examination?

The students with proper eligibility that is 10th Standard / 12th Standard as given in the Eligibility Criteria will be eligible to appear for TNSCVT Examination.

2. Where will the Examination be conducted?

The Examination will be conducted in all the Authorized Vocational Training Centres of TNSCVT all over India.

3. When will the Examination be conducted?

The Examination will be conducted at the closure of particular session. The date of commencement of examination will be intimated through E-Mail and SMS. Also the date sheets of that session will be mailed and uploaded in our website.

4. How many times the Examination will be conducted?

The Examination will be conducted three / four times. The decision for number of times, TNSCVT Examination will be conducted lies with Academic Council.

5. Where can I download the form for appearing for TNSCVT Examination?

There is no separate application form for TNSCVT Examination. Filling the Student Application Form and submitting along with requisite fees is sufficient for appearing for Examination. The Student Application Form is available online at www.tnscvt.org under Downloads Menu.

6. Can I attend the Examination without clearing the fees or on partial clearance of fees?

Vocational Training Centre (VTC) is any one of the affiliated centres of RAM VTC which trains students in any one or more of the trades as specified by TNSCVT.

7. Is it mandatory to fill all the columns in the Student Application Form?

Yes, it is mandatory to fill all the columns in the Student Application Form along with course and subjects. Incomplete Application Forms will be rejected and returned to the concerned person. In case of any doubts in filling the application form you can call us or mail us.

8. What are the modes of payment of fees?

You can pay through Cash / Demand Draft / Online (NEFT/RTGS)

9. How will I know that I am confirmed to appear for TNSCVT Examination?

You will receive Admit Card and Answer Sheets and it is a confirmation that you are eligible to appear for Examination.

10. How will the question papers be sent?

On the day of examination, the question paper will be mailed in the morning..

11. How many days will I get to answer my question papers?

Date Sheet will be sent and exam needs to be conducted accordingly and the examination needs to be completed on a day-to-day basis.

12. What is the question paper pattern followed in the examination?

The question paper will be descriptive type and it will contain 12 questions out of which the student has to answer 10 questions and all questions carry equal marks.

13. The last paper is Internship Training. What should I do on this day?

TNSCVT conducts the examination following the model of IIEP which is Industry Internship Education Programme, where the theory part will be learnt by the students while the practical is the place of work. So the candidate has to obtain signature and seal from the place of work from the reporting authority at work and needs to be submitted along with answer sheets.

14. When should I submit the answer sheets?

On the last day of Examination, all the answer sheets along with original attendance sheets should be packed and sent back to us. Also the POD tracking number needs to be messaged or mailed to us on the same day.

15. What will happen if I am unable to send the answer sheets during the prescribed timeframe?

The Student will be marked absent and has to reappear for examination in the forthcoming session.

16. What if I fail in any subject?

The student has to pay Rs.400/- per paper and has to appear for examination in the forthcoming session.

17. When will the results be announced?

The results will be announced in 30-45 days from the date of submission of answer sheets.

18. Where can I check the results?

The results will be published online and the information about it will be messaged. You can follow the link given to check the result by typing the enrolment number. http://www.tamilnaducouncil.ac.in/result/index.php

19. What should I do if there is any correction in the results?

If there is any correction in the results, kindly take a snapshot of the result, circle the mistake and write the correct information beside it and send a mail. If needed proof of the document also may have to be submitted. On verifying the information, the correction will be updated in the results

20. How long can I take to check and verify the correctness of results?

Usually a week's time will be given to check and verify the correctness of results. After that any correction required will be chargeable with a fine of Rs.1000/-

21. When will I get mark sheet and certificate?

The mark sheet and certificate will be issued in 30-45 days from the date of publication of the result.

22. What is the mode of verification of mark sheets and certificates?

A person or an institution requiring verification of mark sheets and certificates need to submit photo copy if the mark sheets along with fees of Rs.500/- through Demand Draft to Tamilnadu Council for Open and Distance Learning payable at Chennai. A verification letter will be sent to the concerned person / institution within 7 working days. Online verification is not entertained.
